<b>Slips trips and falls:</b>	Staff and visitors may be injured if they trip over objects or slip on spillages.	<ul style="list-style-type: none"> <li>■ We carry out general good housekeeping.</li> <li>■ All areas are well lit including stairs.</li> <li>■ There are no trailing leads or cables.</li> <li>■ Staff to keep work areas clear, e.g. no boxes left in walkways, deliveries stored immediately.</li> <li>■ Children's buggies are not permitted in the hall due to the risk of depositing sand, mud, water or other unwanted substances from their wheels.</li> <li>■ Users know (through hire agreement) to clear up spillages immediately and know where equipment for this is kept.</li> <li>■ Clearing snow and ice from area immediately to front of main door.</li> </ul>	<p>Good housekeeping is needed in kitchen area, and both halls to ensure any spills are cleaned up immediately.</p> <p>Check that the domestic assistant knows which type of products to use on which type of floor.</p>	All staff, Manager to monitor.
<b>Manual handling: Handling items such as chairs, tables and deliveries.</b>	Staff may suffer injuries such as strains or bruising from handling objects which are either heavy or awkward to move.	<ul style="list-style-type: none"> <li>■ Ingredients bought in package sizes that are light enough for easy handling.</li> <li>■ Commonly used items and heavy stock stored on shelves at waist height.</li> <li>■ Suitable mobile steps provided and staff trained to use them safely.</li> <li>■ Handling aids provided for movement of large/heavy items.</li> <li>■ Sink at good height to avoid stooping.</li> <li>■ Staff trained in how to lift safely.</li> </ul>	<p>Ensure team working for moving heavier items, get assistance.</p> <p>Ensure groups who are likely to be moving objects know where trolleys are stored.</p>	All staff, Manager to monitor.
<b>Public health: Reducing the risk of virus transmission:</b>	Staff and visitors may contract or transmit a virus, with a large amount of the public moving about both Centres.	<ul style="list-style-type: none"> <li>■ Staff are encouraged to wash their hands when they come into the Centre.</li> <li>■ Sanitizer is available around both Centres for staff and visitors to use.</li> <li>■ Anti-bacterial sprays are available around both Centres to clean equipment.</li> <li>■ Both Centres are cleaned daily</li> </ul>	If there is a pandemic, ensure the Committee and Staff follow government guidelines and operate the Centres appropriately.	All staff, Manager to monitor.
<b>Child attendance – Door Access: Children running out of building.</b>  <b>Intruder entering the building.</b>	<p>Child may run out of the building through fire door or exit door.</p> <p>An unwanted person may enter the building and hide in a space with intent to harm.</p>	<ul style="list-style-type: none"> <li>■ Activity leaders are encouraged to keep fire doors closed. If fire doors are opened, activity leaders should keep an eye on them and watch for any potential entrance or exit.</li> <li>■ Out with staffing hours, exit doors should be manned by an activity leader or helper to let visitors in and out of the building.</li> <li>■ No exit doors should be left propped open.</li> </ul>	We insist that activities and private hirers keep their visitors safe, ensure doors are closed and locked out with staffing hours, and building access codes/keys are not handed out to anyone that shouldn't be in possession of them.	All staff, Manager to monitor.

<b>Knives or sharp tools:</b>	Staff could suffer cuts from contact with blades.	<ul style="list-style-type: none"> <li>■ Staff trained in the handling of knives.</li> <li>■ Knives suitably stored when not in use.</li> <li>■ First-aid box provided.</li> </ul>	Tell staff not to use knives to open Packaging, suitable cutters will be provided.	All staff, Manager to monitor.
<b>Kitchen Use:</b>	<p>Visitors can prepare and serve food from the kitchen where basic hygiene is required.</p> <p>Oven in kitchen may become scalding when in use.</p>	<ul style="list-style-type: none"> <li>■ Signs displayed for hand washing.</li> <li>■ Cleaning products are provided to keep surfaces clean.</li> <li>■ Oven marked with caution sign.</li> </ul>	<p>Inform visitors to keep kitchen area clean and tidy when they use it.</p> <p>Adults will be advised that all children should be accompanied by an adult in the kitchen.</p> <p>A child proof lock will attached to the cupboard in the kitchen containing cleaning products.</p>	All staff, Manager to monitor.
<b>First Aid:</b>	Staff or users may have issues if there are no first aid trained staff or the first aid kits are not stocked correctly.	<ul style="list-style-type: none"> <li>■ Staff are first aid trained.</li> <li>■ First aid kits are checked regularly and kept stocked with the correct equipment.</li> <li>■ Defib units are checked to ensure the battery is working and the pads are in date.</li> </ul>	<p>Ensure that activity leaders are first aid trained.</p> <p>Inform public and activity leaders of where the first aid kits are located.</p>	All staff, Manager to monitor.
<b>Electricity:</b>	Staff or users could suffer serious injuries or burns as a result of electric shock caused by faulty equipment or installation.	<ul style="list-style-type: none"> <li>■ Manager/staff to visually inspect the system on an ongoing basis.</li> <li>■ Fixed installation to be inspected and tested by an electrician on a regular basis.</li> <li>■ Staff prompted to check equipment before use and to report any defects such as hot plugs, discoloured sockets, or damaged cables and equipment.</li> <li>■ Access to fuse box kept clear, and staff know how to safely switch off electricity in an emergency.</li> <li>■ Plugs and sockets are appropriate for kitchen environment.</li> <li>■ A current PAT test to be in place for all portable appliances.</li> <li>■ Private hire users are aware they are responsible for any equipment used on site.</li> </ul>	<p>P.A.T. testing to be done on a yearly basis by a competent tester.</p> <p>A qualified electrician to inspect the electrical system and advise on frequency of testing.</p> <p>Fuse box to be clearly labelled.</p>	All staff, Manager to monitor.

<b>Fire:</b>	If trapped, staff or customers could suffer serious/fatal injuries from burns or smoke inhalation.	<ul style="list-style-type: none"> <li>■ Fire risk assessment done as at <a href="http://www.communities.gov.uk/fire">www.communities.gov.uk/fire</a> and necessary action taken.</li> </ul>	Ensure all actions identified as necessary by the fire risk assessment are done.	All staff, Manager to monitor.
<b>Stored Equipment:</b>	Users could be injured by collapsing stacks of chairs or stored equipment.	<ul style="list-style-type: none"> <li>■ Users made aware that they must stack chairs and equipment carefully so it does not collapse.</li> </ul>	Users to read chair and equipment storage procedures as highlighted in poster within hall storage area.	All staff, Manager to monitor.
<b>Machinery, buffers etc.:</b>	<p>Domestic assistant/staff risk injury from contact with moving parts on machinery.</p> <p>Manual handling injury.</p>	<ul style="list-style-type: none"> <li>■ Staff trained in cleaning, assembly and operating procedures.</li> <li>■ All dangerous parts of machinery suitably guarded.</li> <li>■ Checks of machinery guards before use.</li> <li>■ Staff trained to spot and report any defective machinery.</li> <li>■ Safety-critical repairs carried out by competent person.</li> <li>■ Ensure equipment operating instructions are easy to locate.</li> </ul>	Remind staff to isolate (switch off from power supply) machinery before carrying out maintenance or cleaning an appliance.	All staff, Manager to monitor.
<b>Working at height: Cleaning windows, putting up decorations etc.</b>	Staff risk serious injury from a fall from any height.	<ul style="list-style-type: none"> <li>■ Suitable stepladder securely stored and ready for use.</li> <li>■ Staff trained in safe use of step-ladder.</li> </ul>	<p>Users to check step-ladder condition before use.</p> <p>Get a colleague to hold the step-ladder steady.</p>	All staff, Manager to monitor.
<b>Workplace Temperature:</b>	Staff and users could get too hot or too cold.	<ul style="list-style-type: none"> <li>■ Fans extractors and thermostats provided to control air temperature.</li> <li>■ Staff encouraged to take rest breaks in warmer conditions.</li> </ul>	Encourage staff to take regular drinks of water.	All staff, Manager to monitor.
